They evaluate the works of each Tattoo Artist. All spontaneous applications are assessed in advance, based on the candidate's portfolio and the available stand spaces. No tattoo chains will be allowed to participate. Only tattoo artists with at least 5 years of experience will be admitted (no interns, no tattoo schools). Only after approval, you will receive a final confirmation and invoice of your participation.
